RESEARCH

I am a specialist in the economics of growth and development in low-income economies. My geographic concentration is on Southeast Asia, a region where I have been engaged as a researcher since 1984. The countries of this region have much in common and yet present a wide diversity of economic and political systems, natural resource endowments, and historical experiences. Their globalization has been a strong distinguishing feature in recent times, and I use this as a lens through which to examine and evaluate their development experiences and associated welfare outcomes (poverty, income distribution, and environment) with a view to producing policy-relevant research results. I use mainly trade theory and applied general equilibrium analysis, because these tools enable me to identify and quantify macroeconomic channels (such as labor markets and trade accounts) through which “shocks” from global trade and factor markets, industry-level decision-making, and government policies are transmitted to firms and households economy-wide.
